This Privacy Policy (the “**Policy**”) of the operator - LLC “Stattech” - is intended to protect the personal information that you provide to us. We may receive such data when you use our website at stattech.ru.

Our company is a personal data operator. An entry about us is available in the [Register of Operators](#) on the Roskomnadzor portal.

When the Policy uses the words “we”, “us”, or “company”, it refers to the operator.

What is this Policy about?	In this Policy, we explain how we process your personal data and ensure its security and confidentiality.
What are personal data?	Personal data means any information relating to an identified individual. We collect only the data required to provide the full functionality of our products.
Whose data do we process?	We process personal data of website users. This includes users of the StatTech service and website visitors.
What rights do you have?	Right of access You may request a copy/extract of your data or export it independently. Right to rectification You may ask us to correct inaccurate, incomplete, or outdated data, or you may do so yourself in your account. Right to blocking and deletion You may request that data be blocked or deleted. We will delete it within 30 days after receiving the request. Right to withdraw consent You may withdraw your consent to data processing. In this case, some website functions may become unavailable to you. Right to disable cookies You may delete or block cookies set by the website in your browser settings. Right to receive information You may receive any information about the processing of your data. Right to appeal You may appeal our actions or inaction to a territorial office of Roskomnadzor.

Which web analytics services do we use?	To ensure correct website operation, we use the Yandex Metrika service. Analytics systems process only anonymized cookies that do not allow a specific user to be identified.
<p><i>Cookies are small text files stored on your device when you visit a website. The files are saved by your browser. They contain information about website usage.</i></p> <p><i>Cookies also include local shared objects (Flash cookies), pixel tags (web beacons), and other similar technologies.</i></p>	
How do we process data?	To achieve the stated purposes, we will perform the following actions with the data: collection, recording, systematization, accumulation, storage, clarification (updating, modification), retrieval, use, transfer (provision, access), depersonalization, blocking, deletion, and destruction.
How do we destroy your data?	<p>Procedure for destroying personal data: deletion from the operator's information systems using built-in software tools.</p> <p>If consent is withdrawn, we destroy your personal data within 10 business days, unless there are other lawful grounds for continuing processing. Destruction is confirmed by an act.</p>
How do we ensure data security?	<p>We protect personal data from disclosure, full or partial loss, and unauthorized access by third parties.</p> <p>To do this, we take all necessary technical and organizational measures to ensure security and confidentiality in accordance with articles 18, 18.1, and 19 of Federal Law No. 152-FZ.</p> <p>For example, we:</p> <ul style="list-style-type: none"> • encrypt data • use antivirus software • use intrusion detection and prevention systems (IPS/IDS) • use backup and disaster recovery systems to restore data if it is deleted by mistake or during cyberattacks • regularly update data storage and protection technologies in line with the latest developments <p>If a personal data leak occurs, we:</p> <ul style="list-style-type: none"> • notify Roskomnadzor within 24 hours • conduct our own investigation within 72 hours and inform Roskomnadzor of its results
To whom do we transfer your data?	<p>We do not transfer personal data to third parties without your consent.</p> <p>We may transfer personal data without your consent if:</p> <ul style="list-style-type: none"> • required by law • necessary to prevent fraud <p>Our company is not responsible for the transfer of your data to search engines.</p>

Where do we store data?	We store your personal data on servers located in the Russian Federation.
How do we update the Policy?	<p>Industry standards and business processes are continuously evolving. Therefore, we will amend the Policy if new legal requirements appear or on our own initiative.</p> <p>A new version of the Policy takes effect from the date it is published on the website. We always indicate this date at the end of the document. Continued use of the website means your consent to the new terms of the Policy.</p> <p>We recommend that you review the Policy regularly and monitor updates.</p>
What does the Policy apply to?	<p>Our website may contain links to external resources - third-party websites. The Policy does not apply to such resources. We do not control and are not responsible for external resources that you may access through links available on our website.</p>
What do we not verify?	<p>We cannot verify, therefore you guarantee that you:</p> <ul style="list-style-type: none"> • have full legal capacity • provided your own accurate personal data • will update the data in a timely manner
Do we process children's data?	Our website is not intended for processing personal data of minors. If you have reason to believe that a child has provided us with personal data, please let us know.
How will we resolve disputes?	<p>For any disputes, we will apply the laws of the Russian Federation.</p> <p>This rule applies regardless of your citizenship, place of residence, or location when using the website.</p> <p>Court disputes will be resolved at the location of our company.</p>
